# EQUIPMENT OPERATING PROCEDURES AND GUIDELINES

The **Towaliga & Lamar Soil and Water Conservation Districts** have adopted the following procedures for the rental of the District no-till equipment: *Note: Rates and policies subject to change by vote of the District.* 

- 1. I accept full responsibility for the roller crimper and/or strip tiller and/or strip tiller while it is in my care.
- 2. I will hold harmless the Towaliga Soil and Water Conservation District and any of its agents or supervisors against all claims, damages, or injuries that may arise while I am operating the roller crimper and/or strip tiller and/or strip tiller.
- 3. I will pay for all repair to said roller crimper and/or strip tiller which is a result of or which is caused by my negligence or improper care. I will report to the district or its agent any repairs the roller crimper and/or strip tiller may need.
- 4. I agree not to loan the roller crimper and/or strip tiller to others while it is in my care.
- 5. The roller crimper and/or strip tiller is owned by the Towaliga Soil and Water Conservation District and is intended for the use of the farmers and landowners in the District. It is hoped its use will help further our conservation efforts and that you will care for it as you would your own and that you will report any problems that you may have with it. The fees for the use of this equipment are for the purpose of keeping it in good operating condition. We are not trying to make a profit through its use.
- 6. Your support and cooperation is most appreciated.

**NOTICE:** It is necessary to obtain appropriate paperwork prior to picking up the equipment.

This paperwork can be acquired through the roller crimper and/or strip tiller custodian: Ricky Minter at 283 Hills Bridge Road, Fayetteville, GA 30215. Phone: (404) 202 – 0419. The roller crimper requires 30 HP tractor to operate at maximum capacity.

**Fees and Costs**: \$50.00 Deposit – to be refunded to user upon return of roller crimper and/or strip tiller (unless damage to equipment occurred) with check-in-sheet. Rental rate - \$10.00 per day, or any part of a day
